The University Grading System is outlined in <u>ARP 4.55</u> (https://arp.nmsu.edu/4-55/). Instructors can decide if their course is graded using fractional grading (pluses and minuses). At the request of the student, the instructor will provide information on progress in the course prior to the last day to drop a course.

S/U Grading Option

Incomplete Grades

Under university policy, incompletes may be given only if a student has a passing grade at mid- semester (the last day to withdraw from a class) and is precluded from successful completion of the second half of the course by a documented illness, documented death, family crisis or other similar circumstances beyond the student's control. Six-Week Early Performance Grades

Lower division courses are required to submit grades for work completed as of the sixth (6th) Friday of the semester. These grades will be used to facilitate opportunities for students to address performance issues. This is optional for upper division courses. (<u>ARP 4.55, Part 5</u>)
