Nine-month tenure-track faculty

Please follow the notification schedules below for faculty members whose temporary contracts will not be renewed Departments that are not renewing faculty contracts need to notify those faculty members via a Contract Status and Dossier Review Form (http://provost.nmsu.edu/forms/) and should work with HR Employee & Labor Relations (646-2449) on a notification letter.

Twelve-month tenure-track faculty

For faculty members whose temporary contracts will not be renewed at the end of the 2019–2020 fiscal year, the effective date of termination will be June 30, 2020.

Faculty members in their second year of service at NMSU are notified of nonrenewal by a Contract Status & Dossier Review Form	Friday, November 8, 2019	Friday, December 6, 2019 (ensures 6-month notice)
Faculty members in their first year of service at NMSU are notified of nonrenewal by a Contract Status & Dossier Review Form	Friday, February 21, 2020	Friday, March 13, 2020 (ensures 3-month notice)

Non tenure-track (College) faculty

If the employee's offer letter includes the appointment period with both a start date and an end date, this constitutes written notice. In this instance, the employee should be informed as soon as possible whether employment will be available for the semester or year following the appointment end date. The following schedule gives the minimum written notice for nonrenewal of regular non tenure-track appointments that do not include a written appointment end date.

Departments can collaborate with HR Employee & Labor Relations (646-2449) on a notification letter.

Nine-month non tenure-track faculty with no specified end date

For regular non tenure-track faculty members who will not be renewed after the 2019–2020 academic year, the effective date of nonrenewal will be May 19, 2020. All faculty need to be notified in writing of non-renewal.

Twelve-month non tenure-track faculty with no specified end date

For regular non tenure-track faculty members who will not be renewed at the end of the 2019-2020 fiscal year, the effective date of nonrenewal will be June 30, 2020.

College faculty members in their first	Friday, February 21, 2020	Friday, March 13, 2020

Extension Associates should be notified of non-renewal three months (if in the first year) or six months (if second or more year) prior to their anniversary date.

Please ensure that performance evaluation policies are reviewed and followed for tenure-track and non-tenure-track faculty prior to issuing notification of nonrenewal.
